PROVIDE A BRIEFLY HISTORY OF YOUR ORGANIZATION IN SHERIDAN COUNTY, INCLUDING ANY SERVICES PROVIDED TO AREA RESIDENTS:

The 483-seat capacity WYO Theater was originally built in 1923 as a vaudeville theater called the Lotus. Through the years, it has undergone many changes – in name, décor, and use – but it has always remained an integral part of the Sheridan community. When the doors of the theater closed in 1982, a group of dedicated citizens began the process of raising funds to see that the building would remain standing. In 1983, the City of Sheridan purchased the building and began leasing it to "Save the WYO Inc". During the next six years, over \$1,200,000 was raised from individuals, businesses, and private foundations to renovate the theater. In November 1989, the doors of the newly renovated WYO Theater opened once again to serve the area and its people. Twenty-five years later, with support from many individuals, foundations and community businesses, including a \$2 million grant from the Wyoming Business Council, the WYO and Sheridan College rebuilt and remodeled the adjoining "Perkins Building" to the south; it also expanded the mission by renaming the combined facilities "WYO Performing Arts & Education Center". Then again, in 2016, the WYO and College embarked on the final leg of its expanded vision by remodeling the adjoining "Hallmark Building" to the north again with support from individuals, foundations and community businesses, including another \$2 million grant from the Wyoming Business Council. The WYO continues to offer a wide variety of arts opportunities over these last 28 plus years through theater-sponsored programs in performance and education.
